

NCSS Conference in Ohio

All-day field trip to eastern Ohio scheduled for June 16



Ohio will host the North Central Regional Soil Survey Conference for the first time since 1986 on June 14 to 17 in Columbus. Information about the conference and registration details are at http://soils.usda.gov/partnerships/ ncss/conferences/2010/ north_central/index.html. Preregistration is \$135 through June 4; on-site registration will be \$175. Student registration is \$75. The North Appalachian Experimental Watershed in Coshocton County will be included on the field trip.

2010 Workshop

Plans are being made for AOP's annual workshop to be held sometime in August or early September, probably in central Ohio.

During the annual meeting, Dan Michael reported that soils information is currently mostly ignored in the siting of geo-thermal systems in SW Ohio.

However, soils have different heat transfer rates, which affect the length of piping needed to heat and cool homes

economically.
Environmental issues are also worthy of consideration.

HOUSEHOLD SEWAGE LEGISLATION READY TO MOVE IN OHIO GENERAL ASSEMBLY

A revised edition of Senate Bill 110 is expected to be voted upon in May. The bill's primary sponsor is Tom Niehaus, and it includes many of the recommendations of the commission on which Steve Miller served as AOP's representative in 2008. This bill and a bill introduced by primary sponsors Tim Grendell and Capri Cafaro

(SB 100) were assigned to the Environment and
Natural Resources Committee in April
2009. The Dept. of Health has been
involved in some of the recent

negotiations between Niehaus and Grendell, to allow SB 110 to move forward in the committee. If signed into law, rule-making steps will follow.

OHIO SOIL SURVEY UPDATE



NRCS changes in 2009/2010

Rich Gehring has retired, and Mike Wigginton is the new state soil scientist for the Natural Resources Conservations Service. Gordon Gilmore has retired, and Brian Cooley is now the resource soil scientist for Area 5, in Chillicothe. Don Burgess resigned as the MLRA project leader in Findlay to accept a position with A & L Great Lakes Laboratories in Ft. Wayne. Neil Martin was selected to fill the position. This soil survey office is assigned to the areas in Ohio and Indiana where Blount soils are predominant. Rachael Stull resigned as wetland team leader in Findlay, and the position has been advertised. Jennifer Outcalt has been hired in a cartographer position in Findlay to support soil survey work statewide.

ODNR changes in 2009/2010

The Division of Soil & Water Conservation merged with the Div. of Water to become the Div. of Soil & Water Resources (DSWR). Neil Martin retired as the soil resources program administrator, and Matt Deaton has been selected to fill the role. Tim Gerber was hired to assist temporarily, on a part-time basis. Brian Cooley resigned as the conservation soil scientist based in Marietta. DSWR hopes to

advertise a field soil scientist position by this fall. Jim Svoboda was hired by the Div. of Mineral Resources Management in New Philadelphia.

OSU/OARDC changes in 2009/2010

Jerry Bigham has been succeeded by Ron Hendrick as the new Director for OSU's School of Environment & Natural Resources. Jerry and Don Eckert retired in January, and Frank Calhoun retired in February. WILMINGTON COLLEGE SOIL JUDGING TEAM AT NATIONAL CONTEST



The Wilmington College team placed 3rd in the regional contest held in Ohio last fall and qualified

to go to the national contest at Texas Tech in Lubbock, Texas this spring. The team placed 13th in the contest, but Coach Matt Deaton reported that fewer than 100 points separated them from the 5th place team. Virginia Tech's team won 1st place in the contest.

Team member Alicia Jacquemin placed 14th, only about 70 points below the top individual's score. Other members who competed as individuals were Britt Barry, Andy Wagner, and Josh Ward. Mike McCullough, Thomas Bohrer, and Brandi Fornshell participated in the team part of the contest.
