Fall Workshop Scheduled

Ways to "map" soil spatial variability offered on October 3 & 4



The Fall Workshop will be held at two locations in Central Ohio. President-Elect Bob Parkinson has worked with five others to develop the program, which includes about 12 hours of educational activities.

The first day will involve field investigations to make an Order 1

soil survey on about 15 acres; the second will involve class exercises with GIS tools to produce high intensity maps for client reports.

Agency Comings & Goings

At most annual meetings of the Ohio Academy of Science,

many presentations are offered about soils, but few are presented by soil scientists.

The 2012 meeting will be held in April, but the deadline for submitting papers for it is on November 7.



Sad News

Two internationally-known soil scientists who began their careers in Ohio in the 1960s passed away in June.

Dr. Fred Miller suffered a heart attack while on a rafting trip in the Grand Canyon. He was Chair of OSU's Dept. of Agronomy from 1986 until the soil science part of the department was moved into the School of Natural Resources in 1994. He served as the School's Director until his retirement in 1998. He received two graduate degrees at OSU and served as SSSA President in 1990-91.

Dr. Frank Calhoun was killed in a vehicular accident in The Villages, Florida. He received two degrees at OSU before beginning an international career while employed by Firestone Plantations, the University of Florida, Texas A & M and from 1986 to 2010, OSU. He was responsible for having soil survey laboratory data from about six decades entered into a useful database. A memorial tree is to be planted at OARDC's Secrest Arboretum. SSSA News

Last month, the Soil Science Society of America Board voted to form a new division, S12, for Consulting Soil Scientists. SSSA and the National Society of Consulting Soil Scientists have been discussing integration, and creating the new division is a step in that direction.

IN OTHER STATES

In Texas, the Board of Professional Geoscientists (BPG), which handles licensing for soil scientists, was not eliminated in the new budget. Key testimony helped BPG survive with a funding cut of only ten percent.

Oregon is the 20th state to adopt an official state soil, the Jory soil series. According to a Wikipedia website, Wisconsin was the first to adopt a state soil, in 1983. Mississippi became the 19th one in 2003.

The Earth Sciences and Resources Institute-University of South Carolina and NRCS in the state recently produced a series of engaging videos on soils. Location for Oct. 3: OSU Molly Caren Agricultural Center, Gwynne Conservation Area Cabin, 690

Arbuckle Road W, London, OH 43140. (The Google maps website plots this address at the intersection of Arbuckle Road and Ohio Rt. 38, which is 0.2 miles SE of the lane entrance to the cabin off Arbuckle Road.)

Directions to intersection of US-40 & OH-38 (north of London): From the east, take Exit 79 off I-70 and go southwest on US-42 1.4 miles to US-40; go west 3.0 miles to US-40 & OH-38. From the west, take Exit 72 off I-70 and go southeast on OH-56 about 0.7 mile; go east 2.2 miles to US-40 & OH-38.

Directions from intersection of US-40 & OH-38 to cabin: Go north on OH-38 2.2 miles (past entrance to Molly Caren Agricultural Center headquarters) over I-70 to the intersection with Arbuckle Road on the left. Turn left and go 0.2 miles to the lane entrance on the right. Follow the lane back to gravel parking area.

Location for Oct. 4: Ohio Dept. of Natural Resources' Fountain Square campus, Building I, 2045 Morse

Road, Columbus, OH 43229. (The Google maps website plots this address a short distance west of the entrance into the campus.) Map handouts will be available on Oct. 3. From Exit 116 off I-71, take Morse Road east 1.7 miles to light at new Turkey Hill gas station and turn right; go east on access road and turn right just after passing ODNR sign. Stop at guard station and request visitor pass, then head west toward Menards.

Additional Information and Registration for 2011 AOP Workshop

Lodging options: Driving time between Molly Caren Agricultural Center (MCAC) and ODNR's Fountain Square campus is 40 minutes after the morning rush hour ends. About ten motels are near Exit 91 off I-70, which is about 20 miles east of MCAC. About ten motels are near Exit 117 off I-71, which is about four miles northwest of the ODNR campus. Many other motels are at exits off I-270 north of I-70 and west of I-71.

Field equipment to bring: If possible, bring soil auger(s), spade, color book(s), clinometer or abney level, pH kit, acid bottle, and GPS. Be sure to label any extra equipment that you are willing to lend to others.

Registration: Deadline for early registration rate is **September 6**. One catered lunch is included with registration.

Student members - \$35 (no difference after September 6)

Other members - \$75 early, \$100 after deadline, including at the workshop

Non-members - \$125 early, \$150 after deadline, including at the workshop

The workshop is limited to the first 48 registrants. Fees will be returned to those who attempt to register after registration is closed.
